

TERMS AND CONDITIONS FOR THE “CHAMPION’S OFFER”
(hereinafter referred to as the “Terms and Conditions”)

1. General Provisions

- 1.1. The organiser of the Offer is ALUPROF Spółka Akcyjna, with its registered office at ul. Warszawska 153, 43-300 Bielsko-Biała, Poland, entered in the register of entrepreneurs maintained by the District Court in Bielsko-Biała, 8th Commercial Division of the National Court Register (KRS) under KRS number 0000106225, with a share capital of PLN 4,028,350.00, fully paid up, holding the status of a large enterprise, tax identification number (NIP): 5470242884, statistical number (REGON): 070424429, BDO number: 000004797, website: www.aluprof.com (hereinafter referred to as the “Organiser” or “ALUPROF”).
- 1.2. The Offer is available under the name “CHAMPION’S OFFER” (hereinafter referred to as the “Offer”).
- 1.3. These Terms and Conditions set out the rules governing participation in the Offer, including the rights and obligations of participants.
- 1.4. The Offer is addressed to end customers and distributors. Direct participation in the Offer is available to ALUPROF distributors who meet the conditions specified in these Terms and Conditions (hereinafter referred to as the “Participant” or the “Distributor”).
- 1.5. The Offer applies to the sale of pergolas (as defined in clause 3.1 of these Terms and Conditions) by the Organiser to Distributors. For the purposes of the Offer, the sale of a Pergola shall mean an order placed in the B2B ordering system for a Pergola together with LED Lighting or a heat lamp, where, as a result of placing such an order, it is accepted for production (i.e. a contract is concluded).

2. Duration and Territorial Scope of the Offer

- 2.1. The Offer is valid from 16 March 2026 to 30 June 2026.
- 2.2. ALUPROF reserves the right, at its sole discretion and without providing any reason, to extend, shorten or terminate the Offer at any time.

3. Products Covered by the Offer

- 3.1. The Offer applies to pergolas as finished products from the ALUPROF range, with the following designations:
 - SB 400
 - SB 450
 - SB 550(hereinafter referred to individually or collectively as the “Pergola” or “Pergolas”).
- 3.2. Subject to clause 3.3 of these Terms and Conditions, the Offer includes LED lighting (cool white or warm white) installed in the perimeter frame of the Pergola structure or a heat lamp, hereinafter referred to respectively as the “LED Lighting” and the “Heater”.

3.3. The Offer does not include spot lighting in the roof slats or any other additional elements of the pergola.

4. Conditions of Participation

- 4.1. The Offer is open to any natural person, legal entity or entity without legal personality acting as an ALUPROF distributor.
- 4.2. In order to benefit from the Offer, the Distributor must purchase a Pergola together with LED Lighting or a Heater during the Offer period.
- 4.3. ALUPROF does not collect or process personal data of end customers. Any data that may be obtained in the course of the sales process is processed by the Distributors independently and at their own responsibility, acting as data controllers.
- 4.4. The Distributor, being aware that this Offer forms part of a promotional campaign consisting in the possibility to order a Pergola and receive LED Lighting or a Heater at the price of EUR 1, undertakes that, when making use of the Offer, it will resell (at a price agreed with the end customer) the purchased Pergolas together with the LED Lighting or the Heater at the price of the Pergola (or at the price of the Pergola including installation). The price of EUR 1 constitutes a separate promotional price and means that the LED Lighting or the Heater is not included in the price of the Pergola.

5. Terms of the Offer

- 5.1. The catalogue value of the LED Lighting and the Heater at the Organiser is in accordance with the current price list.
- 5.2. The Participant shall receive LED Lighting or a Heater at the price of EUR 1 (as referred to in clause 3.2 of these Terms and Conditions).
- 5.3. The Participant has the right to choose one of the following LED Lighting options:
 - cool white light,
 - warm white light.
- 5.4. Orders for Pergolas together with LED Lighting or a Heater placed after the end date of the Offer, as specified in clause 2.1 of these Terms and Conditions, shall not qualify for the Offer.
- 5.5. The Offer may not be combined with any other offers addressed to Participants, unless ALUPROF expressly provides otherwise.

6. Liability

- 6.1. The Organiser shall not be liable for the content or performance of the sales contract concluded between the end customer and the Participant; liability towards the end customer shall rest with the Distributor.
- 6.2. Any complaints relating to the Pergola shall be submitted by the end customer to the Distributor in accordance with the applicable rules.
- 6.3. The sale of Pergolas covered by the Offer between the Organiser and the Participant shall be governed by the applicable agreements, the General Terms and Conditions of Sale and Delivery of ALUPROF S.A., the terms of the B2B ordering system, as well as the warranty for finished sun shading products, available at www.aluprof.com and b2b.selt.com.

7. Complaints Relating to the Offer

- 7.1. Complaints relating to the Offer (which do not concern the Pergola) may be submitted to the following e-mail address: promocja@aluprof.com within 14 days of the occurrence giving rise to the complaint. The Organiser reserves the right to request that the complaint be supplemented with any information necessary for its assessment.
- 7.2. Complaints shall be handled on the basis of these Terms and Conditions.
- 7.3. ALUPROF shall handle the complaint within 21 days of receipt.
- 7.4. The response to the complaint shall be sent to the e-mail address provided in the complaint.

8. Final Provisions

- 8.1. These Terms and Conditions are available on the Organiser's websites at www.aluprof.com and b2b.selt.com.
- 8.2. The Organiser reserves the right to amend these Terms and Conditions at any time, including the duration of the Offer, by publishing an updated version on the above websites. Any amendments shall not affect the rights of Participants who purchased a Pergola under the conditions applicable prior to the publication of the amended version.
- 8.3. These Terms and Conditions shall enter into force on the date of their publication on the above websites.
